CONSOLIDATED SCRUTINIZER'S REPORT

To,

The Chairman of the Extra-Ordinay General Meeting (EGM) of the Members of Saregama India Limited (CIN:L22213WB1946PLC014346), held on Tuesday, the 19th day of October, 2021 at 11.00 A.M. (IST) through Video Conferencing ("VC") /Other Audio-Visual Means ("OAVM").

Dear Sir,

- 1. I, Mohan Ram Goenka, Company Secretary in Practice (FCS No. 4515, CP No. 2551), Partner of MR & Associates, was duly appointed as a Scrutinizer by the Board of Directors of Saregama India Limited (the Company) for the purpose of Scrutinizing the process of remote e-voting (i.e., voting remotely, before the EGM, using an electronic voting system on the dates referred to in the Notice calling the EGM) and e-voting during EGM (process of e-voting at the EGM through electronic voting system) on the resolutions contained in the notice dated September 16, 2021 ("Notice") issued in accordance with General Circular Nos. 10/2021 dated 23rd June, 2021, 39/2020 dated 31st Decamber, 2020, 33/2020 dated 28th September, 2020, 22/2020 dated 15th June, 2020 and 17/2020 dated 13th April 2020, issued by Ministry of Corporate Affairs (MCA) (hereinafter referred to as "MCA Circulars"), Government of India, calling the EGM through VC / OAVM. The EGM was convened on Tuesday, 19th October 2021 at 11:00 AM IST through VC / OAVM.
- 2. The Management of the Company is responsible to ensure the Compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronic modes on the resolutions proposed in the Notice of EGM of the Members of the Company dated September 16, 2021. My responsibility as a Scrutinizer for the evoting process (i.e., through remote e-voting and e-voting during EGM) is to ensure that the voting process is conducted in a fair and transparent manner and is restricted to making a Scrutinizer's Report for the votes cast in "favour" or "against" on the resolutions proposed in the Notice of the EGM of the Company, based on the report generated from the e-voting system provided by National Securities Depository Limited (NSDL), the agency engaged by the Company to provide e-voting facility for voting through electronic means and the documents furnished to me electronically for my verification.

- The Members holding ordinary shares as on the "cut-off date" i.e. October 12, 2021 were entitled to vote on the resolutions proposed in the Notice calling the EGM.
- 4. In terms of the aforesaid Notice and as per the provisions of Section 108 of the Companies Act, 2013 (the 2013 Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, and the provisions of Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the remote e-voting facility was kept open from Saturday, October 16, 2021 (09:00 a.m. IST) till Monday, October 18, 2021 (5.00 p.m. IST) and pursuant to MCA Circulars referred above, the Company had also provided e-voting facility during the EGM to the shareholders present at the EGM through VC / OAVM and who had not cast their vote earlier and Members were requested to cast their votes electronically conveying their assent or dissent in respect of the resolution on the e-voting platform provided by NSDL.
- After the closure of e-voting at the EGM, the votes cast were unblocked in the presence of two persons who acted as witnesses as prescribed under sub-rule 4(xii) of Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended.
- 6. Based on the results made available to me, 73 members have casted their votes through remote e-voting platform and 1 member had casted its votes through evoting during EGM. The brief analysis of the results of the voting through Remote evoting and e-voting at the EGM, based on the report generated by NSDL, scrutinized on test-check basis and relied upon by me, are as under:
